- 1. THE BUSINESS: Wealth Re-Distribution** — Eight FinTech platforms guaranteeing participants always receive more value than they contribute — fixing myriad broken industries.
- 2. MARKET SIZE:** \$7T+ combined: Lottery (\$350B), Charitable (\$500B), Gambling (\$100B), Gaming (\$217B), e-Commerce (\$6.3T), Music (\$30B).
